Rules & Regulations of the Lone Star Hunting & Fishing Show

1. Security

The Lone Star Hunting & Fishing Show will provide general facility security during show hours. Exhibitors are responsible for the security of their own booths, merchandise, displays, and personal property at all times.

2. Liability

Exhibitors participate at their own risk and assume all responsibility for any loss, theft, damage, injury, or claims arising from their participation in the event.

3. Insurance

Exhibitors are encouraged to carry adequate liability and property insurance coverage for their products, displays, employees, and equipment during the event.

4. Force Majeure

Should the event be postponed, rescheduled, or canceled due to circumstances beyond management's control, including but not limited to severe weather, natural disasters, government restrictions, acts of terrorism, public health emergencies, or facility issues, exhibitor payments shall be applied to the rescheduled event.

5. Payment Terms

Booth space is not guaranteed until payment is received according to the terms outlined in the exhibitor contract.

6. Refund Policy

All exhibitor payments are non-refundable. If an exhibitor cancels participation for any reason, all payments made shall be forfeited.

7. Booth Assignments

Show management reserves the right to relocate, modify, or reassign booth locations when necessary to improve traffic flow, event operations, or overall show presentation.

8. Conduct

Exhibitors, employees, and representatives are expected to conduct themselves professionally at all times. Show management reserves the right to remove any exhibitor whose behavior is disruptive, offensive, unsafe, or detrimental to the event.

9. Sales & Giveaways

Exhibitors may conduct lawful sales and promotional activities within their assigned booth space. Any raffle, giveaway, contest, or promotional drawing must comply with applicable laws and receive prior approval from show management.

10. Food & Beverage Sales

The sale or distribution of food and beverages may be restricted by venue or concession agreements. Exhibitors must obtain written approval from show management before distributing food or beverage products.

11. Fire & Safety Regulations

All displays, decorations, and booth materials must comply with venue, fire marshal, and safety regulations. Hazardous materials and unsafe displays are prohibited.

12. Compliance with Laws

Exhibitors are responsible for complying with all federal, state, and local laws, including sales tax collection, permits, licenses, and product regulations applicable to their business.

13. Show Management Rights

Lone Star Hunting & Fishing Show management reserves the right to interpret and enforce these rules and to make reasonable decisions necessary for the successful operation of the event.
